All patients receiving an opioid should proactively be dispensed a take-home naloxone (THN) kit and counselled by a pharmacist.



 2020 Canadian national consensus guidelines for naloxone prescribing by pharmacists³ Confirm eligibility⁴

People are eligible to receive a THN kit if:

- They are currently using or may return to using opioids
- They are a family member, friend, or other person able to help someone at risk of an opioid overdose
- Provide the THN kit and offer counselling in a private setting

How to submit claims to Health Network System⁴

Ontario Drug Benefit (ODB) eligible recipients

Follow the normal process; use the following additional information:

Intervention code: PS (Professional Care Services)

Product identification number (PIN): See previous page

Valid pharmacist ID



Eligible recipients WITHOUT an Ontario health card number

Submit the following information:

First name: HARM Last name: REDUCTION

Person's gender: F = female; M = male; or blank
Person's date of birth: Valid YYYYMMDD (if known) or 20000101

Proxy patient ID: 89999 999 91 Intervention code: PS (Professional Care Services)

Product identification number (PIN): See previous page Valid pharmacist ID

Use a reasonable effort to obtain a health card number.

If an eligible recipient does not have or prefers not to give an Ontario health card number, use this information to submit claims.

Use your professional judgement and ensure proper documentation is maintained.
